CONTENT

- ORDER no. 1730 of May 15, 2020 for the amendment of the Order of the Minister of Economy, Energy and Business Environment no. 791/2020 on granting emergency certificates to economic operators whose activity is affected in the context of the SARS-CoV-2 pandemic.
- ▶ DECISION of the Romanian Parliament no. 5 of May 20, 2020 for approving the state of alert and the measures established by Government Decision no. 394/2020 on the declaration of the state of alert and the measures applied during it to prevent and combat the effects of the COVID-19 pandemic.

- Order no. 1730/2020 provides for the following amendments to the Order of the Minister of Economy, Energy and Business Environment no. 791/2020 on granting emergency certificates to economic operators whose activity is affected in the context of the SARS-CoV-2 pandemic:
- Applicants requesting the granting of the Type 2 Certificate (Yellow) will be granted
 this facility based on the declaration on their own liability issued in the form presented
 in Annex no. 3, from which a decrease in revenues of at least 25% in March, April or
 May 2020 results, compared to the average of January and February 2020.
- The Ministry of Economy, Energy and Business Environment may issue emergency certificates, upon request, to economic operators whose activity is affected in the context of the SARS-CoV-2 pandemic until June 15, 2020.
- 2. Decision no. 5/2020 amends and completes Law no. 55/2020:
- In closed public spaces, commercial spaces, means of public transport and at work, it is mandatory to wear a protective mask, under the conditions established by the joint order of the Minister of Health and the Minister of Internal Affairs, issued on the basis of Law no. 55/2020.

- The Government of Romania, through the Ministry of Health, will make available to the local public authorities the necessary protective masks for disadvantaged families and persons within the respective administrative-territorial units.
- Activities of museum institutions, libraries, bookstores, cinemas, film and audiovisual production studios, institutions, including private organizers, performances and / or concerts, cultural centers and / or homes and other cultural institutions, including private organizations, as well as outdoor cultural events and public and private festivals may be held under the conditions established by the joint order of the Minister of Culture and the Minister of Health, issued under Law no.55 / 2020, within 5 days since the adoption of this Decision.
